



Vendors, Welcome to the 2017 Hamel Rodeo

It's our 37th year and once again we will be the largest rodeo in Minnesota. We anticipate record crowds so we invite you to consider being a vendor at this year's extravaganza. **Sorry we can not accept food or beverage vendors.**

Vendor Alley, as we call it, is on grass and next to the main entrance gate so that the majority of spectators will come past the vendor area when arriving and leaving. All booths will be in a lighted area.

The booth rental fee is \$295.00 if postmarked by May 5, 2017 and a guarantee that your name and merchandise will be listed in our program, \$325.00 if paid after that date. This fee also includes electric power to your booth. When the Application for Vendor Space, MN Operator Certificate of Compliance and your payment is received and approved your check/cash/money order will be processed and your application has been accepted.

We ask that your booth be set up and staffed at least two hours before rodeo time. Vendor passes will be given out when you arrive at the rodeo grounds through the contestant gate so you can get in without paying for a ticket. All vendors may be subjected to inspection by the State Electrical Inspector to assure compliance with the State Electrical code.

We look forward to seeing you at our rodeo this year starting Thursday, July 6th through Sunday, July 9th. There will be evening performances on July 7, 8, 9, & 10 starting at 7:30 p.m. The Family Matinee performance on Saturday afternoon July 8th will be at 1:00 p.m. Slack competition will be Thursday morning July 6th starting at 8:00 a.m.
